Cut off date

From Europe

- Sea freight Oct 1st 2022
- Air freight Nov 14th 2022

From U.S.

- Sea freight Sept 15th 2022
- Air freight Nov 9th 2022

Documents required

- ATA carnet/Carnet de passage (One carnet may be used for multiple cars, shipping company could create it)
- Car details
 - Make
 - Model
 - Color
 - Chassis number
 - Engine number
 - Items moving with the car/cars

- Letter of guarantee that the car will leave UAE before the expiry of the carnet (consignee to prepare)
- Passport copy (International individuals)
- Authorization letter to clear the shipment (will provide)



Quotation

To prepare the quotation we will need the following

- Full name
- ID copy
- Contact number
- E-mail address
- Address of collection
- Filled car movement checklist






Upon confirmation of quotation

Once the customer confirms the quote; shipping company will proceed to book the mode of transport, it is very important that the car is ready to be moved 10 - 15 days prior to the shipping date.


Once shipping date is set it will be communicated to the customer.





Customer responsibility

- ATA Carnet/carnet du passage (If customer provide it)
- Items that will move with the car (properly boxed)
- Car/cars to be prepared and ready for shipping





Prior to shipping


- 1. 15 days prior to shipping date, customer will be contacted and all documents reviewed for smooth movement of the car, collection or dropoff date will be set
- 2. Once the car is collected or dropped off, shipping company will fix the car well to the lashing point in the container
- 3. Client will receive weekly updates on the position of the shipment





Arrival to UAE


- 1. Once the cargo arrives to UAE, shipping company will proceed to clear the shipment
- 2. Once cleared, shipping company storage facility will receive the car for cleaning and preparing and cross checking items with ATA carnet/carnet du passage
- 3. Car will be delivered for the event





After the event

- 1. At the end of the event; shipping back to country of origin process will start.
- 2. Booking of voyage date will be set within the month of October. Shipping date to be from the next available date after the 27th of November 2022 preferable within one week, meaning no later than 1st Dec 2022.
- 3. Shipping company will proceed to receive the containers and will fix the car well to the lashing point in the container.





Arrival at country of origin

- 1. Once the car/cars arrive to the origin country, shipping company will proceed to clear the car/cars with its items (if available).
- 2. Once all is cleared the owner/client will be informed that the car/cars and items are ready to pickup or set a date to deliver.
- 3. Cleared documents will be delivered with the car/cars and items if stamped by customs on time or couriered in case of delay at customs stamping.
